

## ESY Camp Site Supervisor

Northern Will County Special Recreation Association (NWCSRA) enhances lives by providing meaningful recreational opportunities for individuals with disabilities. We serve the residents of the Romeoville Recreation Department and Bolingbrook, Lockport and Plainfield Park Districts as an extension of these member agencies. Employees at NWCSRA can expect to experience a variety of benefits including a sense of community, ongoing training, flexible work schedule, recognition, and the ability to make a difference in someone's life.

### Description

This position is a seasonal summer position. Under the supervision of the Youth Services & Day Camp Coordinator, the ESY Camp Site Supervisor will be responsible to plan, organize, lead, and supervise camp supervisory team and activities of campers. As well as, participating in all day camp activities, responsible for the transportation of program participants, staff and volunteers and coaching/mentoring staff. This is a part-time position. Candidates will be working in a team environment & accommodating camp activities throughout the day. Camps are held in both indoor and outdoor environments in various elements.

- Starting pay rate is \$19.00/hour and increases depending on experience and job knowledge.
- This is an hourly, part time non-exempt position. Hours will be set by the Program Coordinator who oversees Summer Day Camp. Candidates will work from 12:00pm-4:00pm Monday - Friday from May 31 (Friday) to June 28 (Friday). Candidates may be expected to work additional hours before the start of, during, and after the completion of camp, as assigned by the Program Coordinator.
- Locations: In a facility that resides in the Valley View School District

## Qualifications

- Must be at least 18 years of age, 21 years of age preferred.
- Must support the mission, vision, and values of the agency.
- Bachelor or Associate degree in Therapeutic Recreation or related field, or working toward attainment of degree, preferred
- Minimum of 2 years of experience working with individuals with special needs
- Supervisory experience preferred
- Must be able to perform the duties and responsibilities independently of others
- Must have transportation to and from program sites
- Valid State of Illinois driver's license and a good driving record
