JOB TITLE: Adult Day Program Team Member

FSLA STATUS: Hourly, part-time non-exempt position

PAY RANGE: \$19.00-\$25.00 per hour

HOURS: Hours will be set by the Program Coordinator that oversees the Adult Day Program and will vary by week. Candidates may work any shifts between the hours of 8:00am-4:30pm Monday through Friday, not to exceed 999 hours per year.

LOCATION: Bolingbrook, Plainfield and/or Romeoville

SUPERVISION: Responsible to the Program Coordinator that oversees the Adult Day Program & Adult Day Program Lead Team Member

JOB SUMMARY: This position is a year-round position. Staff are assigned to work in large or small groups with adults who have disabilities in a recreation setting, participating in both in-house and community-based experiences. Candidates will be working in a team environment, providing fun and engaging experiences for all. Duties include but are not limited to adapting activities and experiences to meet the needs of each individual, assisting with daily living skills, and behavior management.

QUALIFICATIONS:

- Must be at least 21 years of age.
- High school diploma or college degree preferred.
- Minimum of two years of experience working with adults with special needs preferred.
- Must be able to perform the duties and responsibilities independently of others.
- Must have transportation to and from program sites.
- A valid state of Illinois Driver's License with a good driving record and driving experience.
- Ability to drive a 15-passenger vehicle.
- Certification in First Aid/CPR preferred or the ability to maintain within 6 months (training will be made available).
- Certification in CPI preferred or the ability to maintain within 6 months (training will be made available).
- Must support the mission, vision, and values of the agency.

COMPETENCIES:

- **Safety:** Monitor activities, adhere to safety protocols, and be prepared to respond appropriately in emergency situations.
- **Integrity:** Demonstrate honesty, transparency, and ethical behavior in all interactions.
- **Knowledge:** Ability to implement the daily lesson plans as directed by the Adult Day Program Lead Team Member, and willingness to learn and grow in providing recreation opportunities for individuals with disabilities.
- **Communication:** Clearly explain instructions, provide feedback, and offer encouragement to all participants. Follow directions, ask questions, and use active listening skills with colleagues and/or supervisors.
- **Interpersonal Skills:** Appropriately interact with individuals with disabilities, and demonstrate empathy, patience, and the ability to motivate and encourage participants to foster an inclusive and welcoming environment.
- **Professionalism:** Maintain a positive and respectful attitude, adhere to organizational policies, and model appropriate behavior for participants and fellow team members.
- **Adaptability:** Ability to make accommodations for adults with disabilities, adjusting to their changing needs and unforeseen challenges.
- **Reliability:** Ability to be dependable, flexible, punctual, and be ready to perform job duties with commitment and follow-through.
