Executive Director's Report

A. HR/Personnel

- 1. As of the April 11 pay date, NWCSRA part time staff have worked 8,250 hours, earned 206 PLAWA hours, and used 53 hours. (25%)
- 2. Interviews for the Services Manager position have been scheduled.
- 3. Paycom integration continues with back-end work, with full-time staff training on Wednesday, May 7.

B. Recreation

 Inclusion service hours are reflected below. Budgeted inclusion dollars per member agency is calculated at 3% of each member agency's contribution. According to our member agreement, when the budgeted dollars have been used, NWCSRA will bill back the member agency for companion support hours. For our member districts, summer programming uses the most inclusion hours, followed by preschool, and before and after school care.

Below are current inclusion costs per member district, as of 4/21/2025.

2. As of April 21, winter-spring program revenue is \$125,074 and camp revenue at \$71,157.

C. Agency, Technology & Finance

1. NWCSRA received a donation of \$1,000 from Angelic Kindness to put toward adapted equipment.

- 2. With the addition of Bridget, the marketing manager, focused has been on learning current processes, including the brochure and completing the summer brochure, outreach and social media reach to increase awareness of NWCSRA.
- 3. Facebook Live videos were filmed at the youth <u>Kitchen Chemistry program</u>, <u>Romeoville Cruisers' shopping trip</u> to Walmart, and <u>Bedtime Stories event</u> at Bonnie McBeth Learning Center. Facebook analytics March 17-April 13:
 - a. Views increased by 41%; reach increased by 49%; interactions increased by 21%; follows increased by 56%
 - b. The most successful Facebook post, <u>Heart, hustle and hockey</u>, had 3,644 views, reach of 1,823, 49 interactions and 9 shares. The second most engaging post, <u>Woot Woot, Wolves</u>, had 2,525 views, reach of 1,079, 61 interactions and 5 shares. Plus, the <u>April Fool's Day post</u> tricked a few people into believing the Wolves were being renamed the Peaches with 2,193 views, reach of 661 and 70 interactions.

- Staff are scheduling inclusion training with each district for summer camp staff.
- Staff are preparing and planning for the summer season and day camp.
- Summer camp registration has surpassed last year's numbers by 6% for a 7-week day camp. Registration will remain open until May 19th.
- The summer seasonal brochure was posted online April 14 with resident registration opening April 28 and Non-Resident registration beginning May 5.
- Staff have begun planning for fall 2025 programs with new ideas and updates to seasonal programs.
- Staff are excited about the implementation of the newest day program group, which meets 10:00-2:00pm on Tuesdays and Thursdays at the NWCSRA office. This program is geared towards adults who need a little more structure and will be focused on doing in-house activities.
- There are currently 68 participants registered in our Adult Day Program for 2025.

- Two more Adult Day Program team members have been hired and have begun their onboarding.
- The Plainfield Adults Living Large ADP group is participating in a collaboration with St. Francis TR students this month and will be on campus several times for a variety of student led activities.
- The adult day program participants and staff are looking forward to their talent show on May 21.
- Ten Unified Bags teams from NWCSRA will be competing in the Unified Bags Competition held at the Joliet Park District on April 12th. This is only the 3rd year Special Olympics of Illinois has hosted this competition.
- The Wolves Track & Field Team will be competing in the Region E Competition on April 26th & 27th in Joliet.
 Fifteen athletes will compete in several events for the opportunity to advance to the Summer Games being held in Bloomington/Normal on June 20th-22nd. Good luck to our athletes!

Staffing and Trainings

- One coordinator attended the supervisor's symposium at the beginning of April
- The safety committee has been reviewing and putting together the agency SMART goal and working with PDRMA to provide additional lift/transfer training for part time staff
